Coaches Participant Liability Waiver Form

To the best of my knowledge, I am in good physical condition and fully able to participate in all NorCal Hoops LLC events. I am fully aware of the risks and hazards connected with the participation in NorCal Hoops LLC events, including physical injury or even death, and hereby elect to voluntarily participate in said events, knowing that the associated physical activity may be hazardous to me, my property, the property of others, and players / fans / parents within my sphere of influence as a coach.

In addition, I hereby certify that my participation, and the participation of players / fans / parents on any teams I may coach or direct in NorCal Hoops LLC events, meet the criteria outlined in the Amateur Athletic Union rules of participation, including AAU membership requirements. As a coach it is my responsibility to insure that AAU requirements are met, and failure to do such releases NorCal Hoops LLC, and the Amateur Athletic Union, from any liability arising out of such failure.

I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, PROPERTY DAMAGE, OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, any players / fans / parents / coaches that I may coach or mentor, and any loss or damage to property owned by me and others as a result of participation in this event. I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE, NorCal Hoops LLC, their officers, servants, agents, volunteers and employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or anyone within my sphere of influence (players, parents, fans and others), or to any property belonging to me and others, while participating in physical activity, coaching, or while on or upon the premises where a NorCal Hoops LLC event is being conducted.

It is my expressed intent that this release and hold harmless agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVE, DISCHARGE, and CONVENTION TO SUE the above named RELEASEES.

I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be constructed in accordance with the laws of the State of California. In signing this release, I acknowledge and represent that I HAVE READ THE FORGOING Waiver of Liability and Hold Harmless Agreement, UNDERSTAND IT AND SIGN IT VOLUNTARILY as my own free act and deed; no oral representations, statements or inducements, apart from the foregoing written agreements have been made; and I EXECUTE THIS RELEASE FOR FULL, ADEQUATE AND COMPLETE CONSIDERATION FULLY INTENDING TO BE BOUND BY SAME.
